A BILL for establishing RELIGIOUS FREEDOM, printed for the consideration of the PEOPLE.

ELL aware that the opinions and belief of men depend not on their own will, but follow involuntarily the evidence proposed to their minds, that Almighty God hath created the mind free, and manisched his Supreme WILL that free it shall remain, by making it altogether insufceptible of restraint: That all attempts to insuence it by temporal punishments or barthens, or by civil incre pacitations, tend only to beget habits of hypocrify and measurely, and are a departure from the plan of the holy author of our religion, who being ford both of body and mind, yet chose not to propagate it by coercions ou elther, as was in ble Almighty power to do, but to extend it by its influence on realin alone: That the implous preliamption of legiss tors and rulers, civil as well as ecclesiassical, who, being themselves but falliste and uninspired men, have assumed dominion over the saith of others, setting up their own opinions and modes of thinking, as the only true and infallible, and as fuch, endeavouring to impose them on others, bath established and maintained fulle religious over the greatest part of the world, and through all time: That to compel a man, to furnish contributions of money for the propagation of ophilous which he disbelleves and abhors, is figful and tyranaical: That even the forcing him to support this or that teacher of his own religious persuation, is depriving him of the comfortable liberty of giving his contributions to the particular pallor whole morals he would take his pattern, and whole powers he leels most persualive to right couldely, and is withdrawing from the Minitry those temporal rewards which, proceeding from an approbation of their personal conduct, are an additional incitement to carnell and unremitting labour for the infirmation of manhind: That our dvil rights have no dependance on our religious opinions, any more than on our opinion in phyticks or geometry: Tank therefore the portaling any citizen as university the publick confidence, by laying upon him an Incapacity of being called to offices of trust and emolument, unless he profess or renounce this or that we list we list we be a supplied on the control of opinion, is depriving him injuriously of choic privileges and advantages to which, is common with the sellow. directs be but a natural right! That it tends also to carrupt the principles of that very religion it is meant to recurrege, by bribing with a monopoly of wordly bonours and emolumenu, those who will externally reference with and such indeed their are climinal who do not with and such temptation, yet neither are those simocent who lay the balt in their way? That the opinions of men are not the skipest of civil government, nor under its jurisdiction: That to suffer the civil Magistrate to intrude his powers into the held of opinion, and to restrain the prosession or propagation of principles on supposition of their III tendency, Is a dangerous fallacy, which at once destroys all religious liberty; because he being of course Judge of that sendency will take his non opinions the fale of judgment, and approve or condemn the fentiments of others only as they shall square with, or differ from his own: That it is time enough for the rightful purposes of civil government for les officers to interfere when principles break out lato overtache against peace and good order. And finally, that truth is great and will prevail if left to herfelf; that the is the proper and sufficient antigonist to errour, and his nothing to sear from the constite, unless by human interpolition, distributed of her metaral weapons, free argument and debate; errours cealing to be dangerous when it is permitted freely to contradict them.

WE the General Assembly of Virginia do enact, that no man sull be compelled to frequent of support my religious Worship place or Ministry whatsoever, nor sull be enforced, restrained, molesled, or surtherned in his body or goods, nor shall otherwise suffer on account of his religious opinions or belief, but that all men shall be free to protest, and by argument to maintain their opinions in matters of religion, and that the same

stall in no wise diminish, enlarge, or affect wheir dell capacities.

AND though we well know that this Assembly, elected by the people for the ordinary purposes of legislation only, have no power to restrain the acts of succeeding Assembles, constituted with powers equal to our own, and that therefore to declare this act irrevocable would be of no effect in law; yet we are free to declare, and do declare, that the rights hereby asserted are of the natural rights of mankind, and that if any act. Stall be breaster passed to repeal the present, or to natural to operation, such act will be an infringement of matural rights.
